About the IDEA-ICE-3000 Professional Inspector Certification Exam

The IDEA-ICE-3000 Professional Inspector Certification Exam is designed to demonstrate inspection competency for the benefit of all stakeholders. Successful examination provides the employee and the employer with a heightened degree of confidence in the basic working knowledge and research skills of the inspector.

When an employer has ensured that their personnel who conduct visual inspection of product from the excess market have been tested and certified, the company's stakeholders are provided objective evidence and cause for increased confidence in the achievement of customer satisfaction and increased marketability of their products and services.

Prime candidates for this exam are:

- Quality Inspectors
- Quality Engineers
- Quality Managers
- Quality Supervisors

Candidates must be an employee of an OEM, CM, EMS Provider, Government, IDEA General Member, or IDEA Qualified Program Participant Company (QPPC) – Test Services, to meet eligibility requirements for the Exam. Successful completion of an IDEA Training Course does not guarantee eligibility for the Exam. All prospective Exam candidates must contact IDEA prior to submitting an application to confirm they have fulfilled all eligibility requirements.

Those familiar with the Open Market know that performing visual inspections of electronic components requires specialized knowledge and skills of inspection personnel to visually evaluate product and its packaging for substandard and suspect counterfeit characteristics.

The IDEA-ICE-3000 Exam is based on *IDEA-STD-1010: Acceptability of Electronic Components Distributed in the Open Market*, industry standards, and best practices relevant to the Open Market. The Exam is an open book Exam intended to challenge the candidate in practical inspection knowledge as well as access and usage of relevant reference materials in the workplace.

The questions for the Exam are a limited number of questions taken from an evergreen master list of exam questions developed by IDEA. Therefore, the Exams are slightly different versions from candidate to candidate and the order of questions within a test module is shuffled.

Upon successful completion of all test modules with a cumulative score of 95% or higher, the submission of nonconformance photo examples, and corrective action on any questions answered incorrectly, candidates will receive a certificate as objective evidence that they have passed the IDEA-ICE-3000 Professional Inspector Certification Exam and their names will be maintained on record at IDEA as having met this achievement..

The process to certification is as follows:

- Candidate submits the completed application form with payment to IDEA.
- IDEA provides a unique URL for the Exam to the candidate's email address as provided on the application.
- Upon successfully passing the Exam, IDEA mails the candidate's *IDEA-ICE-3000 Professional Inspector Certificate* to the address provided on the application.

Prerequisites for IDEA Qualified Program Participant Company (QPPC) – Test Services Candidates

Note: The IDEA-ICE-3000 Professional Inspector Certification Exam is available to employees of IDEA General Members, IDEA QPPCs – Test Services, OEMs, CMs, EMS Providers, and government entities only. Successful attendance of an IDEA Training Course does not guarantee eligibility for the Exam. All prospective Exam candidates must contact IDEA prior to submitting an Exam application to confirm they have fulfilled all eligibility requirements.

Candidates from an IDEA QPPC – Test Services must meet these specific prerequisites prior to taking the IDEA-ICE-3000 Professional Inspector Certification Exam:

- 1. The candidate must be a current employee of an IDEA QPPC Test Services.
- 2. The candidate must have either supervised or have been a component inspector of electronics components from the Open Market within the last two (2) years and for a total of no less than six (6) months of on the job experience.
- 3. An immediate supervisor or human relations manager must sign the Exam application attesting that the candidate's experience meets the experience qualifications to take the Exam. (Refer to the application form.)
- 4. The candidate must make a declaration of intent to perform fair and objective inspections while executing their inspection tasks to contribute to legal and fair commerce. (Refer to the application form.)
- 5. Contact IDEA at info@idofea.org or 714-670-0200 to confirm all eligibility requirements have been met.
- 6. Upon notification from IDEA that eligibility requirements have been met, complete, sign, and submit the IDEA-ICE-3000 Professional Inspector Certification Exam application form for IDEA approval.
- 7. Remit the application fee to IDEA.
- 8. Notice: These requirements are subject to change without notice.

Requirements to Certification

- 1. Have on record with IDEA an IDEA-ICE-3000 Professional Inspector Certification Exam application form which has been approved by IDEA (for fulfilling eligibility and experience requirements).
- 2. Must have received a cumulative score of 95% or higher in the Test Modules section of the Exam.
- 3. Photos and citations of nonconformance examples have been received and approved.
- 4. Corrective action responses for questions answered incorrectly (5% or less) have been received and are acceptable.

Terms & Conditions

- 1. Purchase must be made in advance of taking the Exam and payment must be submitted with the application.
- 2. The URL for payment by credit card can be accessed at this address: http://www.idofea.org/products/51-idea-ice-3000. IDEA can also invoice as instructed by the purchaser. *Note: The Exam URL will not be released to the candidate until the payment for the Exam has been received by IDEA.*
- 3. Purchases are non-refundable. If the Exam has *not* been started by the original candidate, it may be transferred to another candidate provided that the second candidate submits an application and meets all of the qualification requirements and the transfer occurs within six (6) months of payment.
- 4. The cost of the online Exam is \$395 US for each candidate of an IDEA QPPC Test Services. Prices are subject to change. Volume discounts are available as follows:
 - a. 10% discount for 10 Exams
 - b. 15% discount for 25 to 50 Exams
 - c. 20% discount for 50 or more Exams
- 5. Upon receipt of payment, the candidate will receive an email that provides instructions on how to prepare for and initiate the Exam.
- 6. The Exam must be initiated within six (6) months of purchase. Once started, the Exam must be completed within thirty (30) calendar days from the date the candidate *begins* the Exam.
- 7. If a candidate does not pass the Exam on the first attempt, IDEA's retake policy does not limit the number of times a candidate may retake an examination. The candidate will, however, be charged a retake fee of \$25 after the third retake attempt. The candidate must retake the examination within six (6) months of the last attempt. If a candidate does not retake the Exam within this period, he/she will have to submit a new application with full certification fees.
- 8. The IDEA-ICE-3000 Exam is made up of several individual test modules. Each test is limited to no more than fifteen (15) questions.
- 9. Exam scoring is based on the percentage of the total number of questions presented to the candidate that are answered correctly (raw percentage scoring).
- 10. VERY IMPORTANT Once a *test module* is started, the candidate must either cancel out (all answers will be lost) or complete and submit the test module for scoring. It is therefore *highly recommended* that as candidates answer questions that they personally record their answers in a notebook or in a Word or Excel document in the event that their testing session is interrupted or their computer malfunctions, as under such conditions their answers will not be saved by the online exam software:
 - a. The candidate may decide after reviewing the questions for a particular test module of the Exam that he or she does not want to submit the test module for scoring at this time but would rather review or look up reference materials relative to the questions. In this case, the candidate must cancel out of the test module by clicking on the "X" at the top right of the test module window. When you cancel out of a test module, you can return and start that module all over again. However, any questions that are answered will be lost once the candidate cancels out of a test.
 - b. If the candidate submits a test module for grading and leaves any question unanswered, the unanswered question(s) will be marked as incorrect and will count against the candidate's cumulative score on the Exam.
- 11. At a minimum, candidates will need to review the following reference materials prior to taking the Exam and may refer to them while taking the Exam:

- 13. Recertification by renewal examination is available for up to six (6) months after expiration at renewal pricing. Renewal/recertification pricing is \$250 US for each candidate from an IDEA QPPC Test Services.
- 14. Certificates are subject to revocation or non-renewal if a Certified Inspector is determined to have unresolved quality issues with their employer or multiple transactions that come to the attention of IDEA in writing.
